TIPS FOR YOUR VISIT

- You must pass through courthouse security where you are required to show a photo ID to enter the courthouse.
- Lawyers, including pro hac vice attorneys, who present photo ID and a current bar registration card from this or any other federal or state court may bring in electronic communication devices (<http://www.ksd.uscourts.gov/rule-83-2-4-electronic-communication-devices/>).
- The public may not bring cell phones, cameras, recording devices, or other electronic devices (such as MP3 players). You will be required to return it to your car.

ENTRANCE

Please use the secure entrance located on State Avenue on the south side of the building. The Nebraska Street entrance on the north side of the courthouse is closed to the public.

PARKING

Public and juror parking is available at 1217 5th Street, on the east side of 5th Street, across the street from the First Baptist Church. Do not park in the First Baptist Church lot off Nebraska Street.
